5. The Photographer retains copyright of the photographs but grants the Model unlimited non-exclusive rights to use or reproduce any photographs provided by the photographer for the model's own promotional, non-sale use. Use of any images provided by the photographer for sale must be approved in writing by the photographer.
6. The Model warrants having read and understood this Model Release Agreement and warrants being of full legal age to enter into an agreement. Further, the model acknowledges this document has been entered into and signed in full agreement and without coercion.

7. With full knowledge of the above, the Model hereby releases and shall hold harmless the Photographer and his/her successors, legal representatives, licensees and assigns from all claims or damages including but not limited to defamation or violation of right of privacy or publicity, resulting from or associated with the use of the Work.

8. The Model agrees that the provisions contained herein shall be binding upon the Model and his/her successors, legal representatives and assigns.

9. This Agreement shall be construed, interpreted and governed in accordance with the laws of the State of California and should any provision of this Agreement be judged by an appropriate court as invalid, it shall not affect any of the remaining provisions whatsoever. The parties agree that any or all parts of this agreement may be submitted to the other party in legible and recordable electronic form and upon acknowledgement of receipt by the receiving party shall become valid parts of the agreement.
